

02. **The sanction is subject to the following terms and conditions:-**

- (a) The participants will be treated as on duty during the period of fair ;
- (b) All expenses related to this visit of Hon'ble Minister will be borne by the Cabinet Division, Govt. of Bangladesh;
- (c) Expenses in this connection of the participants mentioned in serial no (3), (4) & (5) will be borne by Bangladesh Tourism Board & serial no (2) will be borne by Bangladesh Parjatan Corporation;
- (d) They will draw their pay and allowances in local currency. No part of it shall be drawn in foreign currency ;
- (e) The delegation would leave Dhaka for Moscow on 22 March 2016 or nearest suitable date and leave Moscow for Dhaka on 27 March 2016 or nearest suitable time ;
- (f) Honourable Minister would attend the 45th celebration of Bangladesh Independence day in Moscow and leave for Dhaka on 29 March 2016 or nearest suitable time ;
- (g) Honourable Minister will be accompanied by his spouse Mrs Lutfun Nessa Khan. All expenses related to her travel will be borne by Honourable Minister.
- (h) They have to submit a report on the fair/visit to this Ministry within 07 days of their return.


